GymSports New Zealand Incorporated Region Regulation

1. Purpose and Status of Regulation

- 1.1 The purpose of this Regulation is to set out the regions agreed by the members of GymSports NZ at a Special General Meeting held by postal vote on 1 December 2007. This Regulation is required due to the completion of the work in the previous Transition Regulation.
- 1.2 This Regulation was adopted by the GymSports NZ Board on 26 August 2011 in accordance with Rule 24 of the Constitution.

2. Commencement Date

- 2.1 This Regulation, as revised, shall take effect and come into force on 29 August 2011.

3. Definitions

- 3.1 Every reference to the Constitution shall mean the GymSports NZ Constitution unless specified otherwise.
- 3.2 The words and phrases used in this Regulation shall have the same meaning as defined in the Constitution unless otherwise specified.
- 3.3 In addition to clauses 3.1 and 3.2 of this Regulation, the following words and phrases used in this Regulation shall mean as follows:

 "Commencement Date" means the date this Regulation, as revised, came into force, namely 29 August 2011.

4. Regions

- 4.1 GymSports shall be divided into six (6) Regions for the purposes of the governance and management of GymSports NZ.
- 4.2 The geographical area of each Region shall be as described and depicted in Schedule 1 to this Regulation.

- 4.3 Subject to clause 4.4, each Region shall be known as follows:
- a. GymSports Northern
 - b. GymSports Auckland/Manukau
 - c. GymSports Midlands
 - d. GymSports Central
 - e. GymSports Upper South
 - f. GymSports Southern
- 4.4 The Board may change the name, number and geographical boundaries of any Region in accordance with the Constitution in consultation with the Regional Boards. In addition, the Board may approve one or more names for a Region, or any of its events, activities or programmes, upon the recommendation of the CEO and/or Regional Board of that Region.

SCHEDULE 1

The geographical boundaries of the Regions shall be as defined by the boundaries of the following Councils:

GymSports North - the Northland Regional Council, the Far North District Council, Whangarei District Council, Kaipara District Council, North Shore City Council and the Rodney District Council
